## I. INTRODUCTION

The 17th Council of Europe Conference of Ministers responsible for Sport is organised by the Council of Europe Enlarged Partial Agreement on Sport (EPAS) in co-operation with the Ministry of Youth and Sports of the Republic of Türkiye.

Participants will assess progress achieved since the last Conference (Athens and online, November 2020 – February 2021) and will discuss two highly topical and interrelated thematic:

Theme 1: Sport for all: uniting us for stronger societies

Theme 2: Rethinking sport: leading the way for a healthy and sustainable future

### Special ceremony (to be confirmed)

A ceremony for the signature and/or ratification of the following Council of Europe Conventions will be organised where appropriate:

- the Convention on the Manipulation of Sports Competitions (CETS No 215);
- the Convention on an integrated Safety, Security and Service Approach at Football Matches and other Sports Events (CETS No 218);
- the additional protocol to the anti-doping Convention (ETS No. 188).

## **VII. INTERPRETATION**

During the plenary session of the conference (26 October 2022) simultaneous interpretation will be provided to and from English, French and Turkish.

During the Meeting of Senior Officials (25 October 2022), simultaneous interpretation will only be provided in English and French.

During the Side-event on the Integration of Refugees and Migrants through Sport (27 October 2022), simultaneous interpretation will only be provided in English, French and Turkish.

During the Social and Cultural Programme (27 October 2022), information will be provided in English and French.

## **VIII. LOGISTICS**

### **8.1 Travel**

All persons travelling to Türkiye must be in possession of a valid passport or official travel document.

Transfer time between the Antalya International airport and the Cornelia Diamond hotel is approximately 30 minutes (covered by the Turkish authorities, see point 8.4).

### **8.2 Hotels**

The Ministers/Heads of delegations and the members of the delegations will stay in the Cornelia Diamond.

For logistical and security reasons, all the other participants are also invited to register to stay in the Cornelia Diamond.

An **external participation fee** will be charged by the Cornelia Diamond to the participants who decide to stay in another hotel in order to cover the all-inclusive service offered by the hotel (please see 8.3).

Rates have been negotiated with the Cornelia Diamond. To check the available rates, please use the registration form or the section "PRACTICAL INFORMATION" on the website of the conference: **[www.sportsantalya.com](http://www.sportsantalya.com)**.

All members of the delegations and other participants should make their hotel reservation using the registration form on the above-mentioned website before **16 September 2022**.

### **8.3 Costs**

Accommodation costs for the Heads of national delegations (in principle, Ministers) at the Cornelia Diamond will be covered by the Turkish authorities for 3 nights.

EPAS will cover the accommodation costs of one further delegate from every State invited to the conference (46 Council of Europe members States + Canada, Israel, Morocco, Holy See and Kazakhstan) at the Cornelia Diamond for 3 nights maximum.

Only delegates registered before 16 September 2022 will be eligible for this financial participation.

Participants whose accommodation costs are not covered by the Turkish authorities nor by EPAS will abide with booking instructions at the hotel and, in any event, settle their bill directly at the reception desk before their departure. Booking of the aforementioned participants can also be supported by the Ministerial Conference Secretariat.



Participants who decide to stay in another hotel will have to settle an **external participant fee** in order to use the all-inclusive services offered by the Cornelia Diamond. The daily amount of this fee is **80€ including VAT** (between 9:00am and 9:30pm).

A Gala Dinner will be given on 26 October under the auspices of H.E. Mehmet Muharrem Kasapoğlu, Ph.D., Minister of Youth and Sports of the Republic of Türkiye in honour of all Ministers, Heads of Organisations and Delegates.

#### **8.4 Local transport**

The host authorities will organise local return transport for all participants during the conference (from 24 to 28 October) between Antalya International airport and the Cornelia Diamond.

*If local embassies are providing transport for their respective ministers, the delegations should inform the host authorities.*

An **Information Point** will be set up in the arrival hall of Antalya International airport. However, no special arrangements are planned for participants arriving in Antalya by car or train.

The **VIP lounge** at the airports in İstanbul, Antalya and other cities (if needed) will be reserved for the Ministers, Heads of Organisations and Delegates travelling with them on a reciprocal basis, upon both arrival and departure.

In order to facilitate the organisation of local transport, participants are required to provide details of their travel itinerary through the on-line conference registration form.

#### **8.5 Visas**

Participants are responsible for verifying the visa requirements and for obtaining visas. For the necessary information about visa regime please visit: <http://www.mfa.gov.tr/visa-information-for-foreigners.en.mfa>. Please note that Türkiye is not part of the Schengen Area.

For visa application purposes, the Turkish authorities and the Secretariat General of the Council of Europe will provide participants with an official letter of invitation and a personal "Note verbale". If participants are

applying for a visa, they are required to tick "Yes, I need an official invitation letter" in the on-line conference registration form.

As of now, there are no covid restrictions on entry and exit to Türkiye.

## **8.6 Bilateral Meetings**

The Ministry of Youth and Sports of the Republic of Türkiye will provide two bilateral meeting rooms for the Heads of delegations, Ministers in particular, on 25 and 26 October 2022. Delegates who wish to have a bilateral meeting and use the bilateral meeting rooms should coordinate with the Ministerial Conference Secretariat in writing via its e-mail address. Allocation of the meeting rooms will be provided on the basis of first-come-first-served.
